Subject:- Grant of Ex-gratia payment to the pensioners/family pensioners of Non-Govt. Colleges for the year 2025-2026.

The Govt. of West Bengal, Department of Higher Education, Budget Branch in their Memo No. 91-HED-13014(99)/3/2025-BDG SEC dated 13/03/2026 have sanctioned payment of ex-gratia grant of **Rs.3,800/-** (Rupees Three Thousand Five Hundred only) in lump per head to all teaching/non-teaching pensioners / family pensioners of Govt. Aided Colleges including the holders of provisional pension who retired prior to 30.09.2025 and also the pensioners who retired or died after 30.09.2025 but prior to 01.09.2026 and are not eligible to receive ad-hoc bonus .

2. The benefit will be admissible only to the pensioners/family pensioners whose basic pension/family pension along with dearness relief as on 31st March 2026 did not exceed Rs. 40,000/-(Rupees Fourty Thousand) only. The benefit is not admissible to those who are entitled to ad-hoc bonus sanctioned by the Government and those who are employed / re-employed under any Public Undertaking / Statutory Bodies / Non-Government Educational Institutions and are in receipt of bonus or ex-gratia payment in lieu thereof during the current financial year.

3. All concerned Pension Disbursing Officers are, therefore, requested to allow ex-gratia grant @ **Rs.3800/-** (Rupees Three Thousand Eight Hundred) only in lump per head.

4. The payment of ex-gratia as sanctioned in the Memo should be made to the **Muslim Pensioners/family pensioners immediately** and **other than** Muslim Pensioners/Family pensioners, the payment in this regard may be made in **between 28/09/2026 to 01/10/2026**.

5. In case of any doubt/difficulty, the matter may be referred to this office for clarification.

**Sub:- Ex-gratia grant for the year 2025-2026 to the pensioners/family pensioners of Ex-Management Staff
of North Bengal Medical College& Burdwan Medical College**

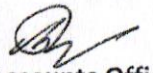
It is informed that the Govt. of West Bengal Higher Education Department, Budget Branch in their Memo No. 92-HED-13014(99)/3/2025-BDG SEC Dated 13/03/2026 have sanctioned ex-gratia grant for the year 2025-2026, @Rs. 3,800/- (Rupees three thousand eight hundred) only in lump per head to the pensioners of State Aided Universities including the holders of provisional pension who retired prior to 30.09.2025 and also the pensioners who retired or died after 30.09.2025 but prior to 01.09.2026 and whose basic pension plus Dearness relief on pension as on March 31st 2026 did not exceed Rs. 40,000/- (Rupees Fourty thousand) only and are not entitled to receive ad-hoc bonus.

The aforesaid benefit will also be admissible to the pensioner/family pensioner who retired/died in harness as Ex-Management Staff of North Bengal Medical College or Burdwan Medical College who opted for University Pension Rules and whose pension/family pension has been regulated either under G.O. No. 83-Edn(U)/84-Edn(U)/85-Edn(U) all dated 30/1/2000 or G.O. No. 464-Edn(U) dated 13/8/2010 (communicated under this office circular No.Pen.Co-ordn/258/Vol-II/228 dated 3/2/2012 and Pen. Co-ordn. /217/Vol -II/220 dated 21/12/2012).

The aforesaid benefit will not, however, be admissible to the pensioners/family pensioners who are entitled to get ad-hoc bonus and those who are employed/re-employed under any public sector undertaking/statutory bodies/Non-Govt. Educational Institution under the Govt. are in receipt of bonus or ex-gratia payment during the current financial year .

The payment of ex-gratia as sanctioned in the Memo may be made to the **Muslim Pensioners/family pensioners immediately** and **other than Muslim Pensioners/Family pensioners**, the payment in this regard may be disbursed in **between 28/09/2026 to 01/10/2026**.

Accordingly, all Pension Disbursing Officers are requested to make necessary arrangements for payment of Ex-gratia @ Rs. 3,800/- (Rupees three thousand eight hundred only) to all eligible pensioners/family pensioners who retired/died in harness as Ex-Management Staff of North Bengal Medical College or Burdwan Medical College and whose P.P.O.s bear the indication "University Pension Rules", subject to fulfillment of the conditions mentioned above.
