Subject : Grant of Dearness Relief @ 58% to the Retired Judicial Officers / family pensioners of the State of West Bengal - revised rate effective from 01/07/2025

The Government of West Bengal, Judicial Department under their letter No. I/697563/2025/JD/V/2A-14/17 dated 09/10/2025 has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been **enhanced from 55% to 58% with effect from 01/07/2025.**

pm/04/ Accordingly, in continuation to this office circular No. Pen. Co-ordn./65 Vol.VI/18 dated 06/05/2025, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ **58%** to the above category of pensioners / family pensioners with effect from **01/07/2025** where pension/family pension has been revised as per instruction of this office circular issued vide No. Pen. Co-ordn./65 Vol. V/94 dated 27/09/2023 read with Pen. Co-ordn./65 Vol. VI/96 dated 20/09/2024, after proper adjustments of payment already made.

Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Charges for payment are debitable to the Govt. of West Bengal, under head 2071 – Pension and other Retirement Benefits – 01 – Civil – 101 Superannuation and Retirement allowances etc.
